

Capital Markets Snapshot

Week ending August 25, 2023

The market was focused on the Federal Reserve's Symposium in Jackson Hole, Wyoming this week, most notably Chairman Powell's speech on Friday. While no significant changes were mentioned, Powell acknowledged that although inflation has come down from its peak, it remains too high above the Fed's preferred target. He noted that any future rate moves will continue to depend on incoming data and they are prepared to keep rates at a "restrictive level" until inflation trends lower.

Fixed Income Markets Overview

- Following Chairman Powell's comments, the 2-year U.S.
 Treasury rose above 5.00% where it has not been since March of this year.
- Economic data during the week showed some signs of a slowing economy. U.S. Durable Goods orders fell by 5.2% in July, which was the largest decline in 3 years. Existing home sales fell by 2.2% last month due to higher mortgage rates and a lack of housing supply. This marked a decline of 16.6% from last year's level.
- Mortgage rates continued to climb higher with the average 30-year mortgage loan rising to 7.23% from 7.09% the previous week, according to Freddie Mac.

Equity Markets Overview

- The S&P and Nasdaq both posted gains for the week, but the Dow Jones was down slightly.
- Equity sectors were mixed with Information Technology leading with a gain of 2.6%, while Energy had the biggest decline at -1.4%.
- Nvidia was the stock focus of the week as the company reported earnings that exceeded analysts' estimates and issued optimistic guidance for the third quarter.
- Earnings reports from retailers came in mixed with Dicks Sporting Goods, Dollar Tree, and Macys all falling below estimates due to a slowdown in sales. However, Neiman Marcus and Abercrombie and Fitch were among stores that reported positive sales trends, which helped them exceed analysts' estimates.

- The U.S. Treasury Department issued proposed rules for the cryptocurrency industry this week, including a customized tax form. The proposal is open for comment until October 30th.

- The August Non-Farm Payroll report will be released on Friday. Current expectations are looking for a gain of 170,000 jobs, down slightly from the July report
