

# Capital Markets Snapshot

Week ending October 6, 2023

A surprising September non-farm payroll report on Friday reflected strong U.S. job growth without increasing wage pressures. The markets initially had a negative reaction to the headline payroll number of 336,000 jobs, but rallied back after a deeper look into the report showed slowing wage pressure with a monthly increase of just 0.2%. Several economists stated this may be the “soft landing” the Federal Reserve has been hoping for, but further data will need to be monitored to see if the trend continues.

## Fixed Income Markets Overview

- U.S. Treasury yields were higher following Friday's jobs report with the 30-year yield breaking above 5.00% before pulling back.
- Despite the recent rise in rates, the yield curve remains inverted with the spread between the 2- and 10-year U.S. Treasury at -29 basis points as of Friday.
- As of the close of the week, the CME Fedwatch Tool showed a 72% chance of the FOMC keeping rates steady at their November 1st meeting.

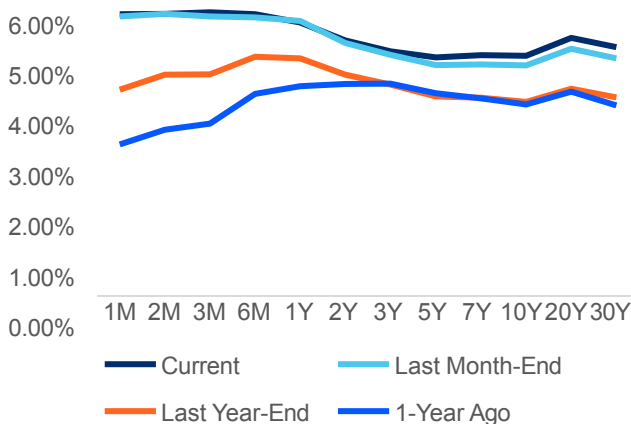

## Equity Markets Overview

- It was a mixed week for the major equity indices with the Nasdaq up 1.6%, the S&P 500 up 0.5%, but the Dow Jones down 0.2%. Sectors were also mixed with Energy falling by 5.4% while Communication Services was the leader of the week up 3.2%.
- Stocks were down earlier in the week following the release of the job openings and labor turnover (JOLTS) report, which showed the number of open positions in the U.S. increased by 690,000 in August.
- Third quarter earnings season will start this week with releases scheduled from Pepsico, Delta Airlines, and Walgreens. Friday will also see several key financial company reports, including JP Morgan, Citigroup, and Wells Fargo.

- U.S. equity futures were under pressure on Sunday following the weekend violence in the Middle East. Oil futures were also higher on this news.
